**ORDER**

The Arkansas Cemetery Board (“Board”) held its quarterly meeting on September 30, 2008, pursuant to Ark. Code Ann. § 20-17-1005 and Rule 4 of the Rules of the Arkansas Cemetery Board. Among the matters considered was an examination report of the books and records of Cave Hill Cemetery No. 2 (“Cave Hill Cemetery”). Upon consideration of the testimony of the witnesses, the exhibits, and all other matters presented, the Board hereby finds and concludes:

**FINDINGS OF FACT**

1. Cave Hill Cemetery is a perpetual care cemetery in Hope, Arkansas, within the meaning of the Cemetery Act for Perpetually Maintained Cemeteries, Ark. Code Ann. §§ 20-17-1001 through 20-17-1029 (“Act”).
2. Cave Hill Cemetery is owned and operated by Sebrena Chambers and Andrew Chambers.
3. On April 17, 2008, the Board issued Order No. C-08-039-08-OR01 directing the staff of the Arkansas Securities Department (“Staff”) to conduct an examination of the books and records of Cave Hill Cemetery in order to determine compliance with the Act and the Rules of the Arkansas Cemetery Board (“Rules”).

4. The Staff presented its findings to the Board at its June 25, 2008, meeting. The Board deferred this item until its next quarterly meeting to allow Cave Hill Cemetery an opportunity to comply with the Act and the Rules.
5. The Staff reported that it conducted a second examination of Cave Hill Cemetery's books and records on September 9, 2008. The Staff advised the Board that Cave Hill Cemetery had cured the deficiencies in its books and records and is currently in compliance with the Act and the Rules.

**CONCLUSIONS OF LAW**

6. The Board is authorized to conduct reasonable, special, or other examinations of any cemetery or cemetery company, including, but not limited to, an examination of the books and records of the cemetery. Ark. Code Ann § 20-17-1006(1).

**ORDER**


